2. Demand

- 2.1. 3. Guarantor's Liability

- 3.1. The Guarantor/s shall not be discharged by time or any other concessions given to the Company or any third party by Shamir UK Ltd or by anything Shamir UK Ltd may do or omit to do or by any other dealing or thing which, but for this provision, would or might discharge the Guarantor/s.
- 3.2. This Guarantee shall:
 - 3.2.1 be in addition to any other guarantee or security held by Shamir UK Ltd at any time for the indebtedness;
 - 3.2.2 be a continuing guarantee, shall not be discharged by any intermediate settlement of the indebtedness and shall remain in effect until the indebtedness is discharged in full;
 - 3.2.3 remain in force notwithstanding (and the Guarantor's obligations under this guarantee shall not be impaired, affected or discharged by) any failure, defect, illegality or unenforceability of or in any of the Company's obligations in respect of the indebtedness;
 - 3.2.4 where given by more than one person, be binding on each such person jointly and severally; and
 - 3.2.5 enure for the benefit of Shamir UK Ltd, its successors and assigns.

4. Law

- 4.1. This agreement and any dispute or claim arising out of or in connection with it shall be governed by and construed in accordance with English law.
- 4.2. All disputes or claims arising out of or relating to this agreement shall be subject to the exclusive jurisdiction of the English Courts, to which the parties irrevocably submit.
